1. Destination Management Plan – Kaipara

Di Miller (PGF Project Manager), Tania Burt and Jude Thompson (Northland Inc representatives) presented this item.

The following matters were raised:

- It was noted that there is a need to ensure that investment in infrastructure supports domestic tourism, with clarity on who should pay for it
- It was emphasised that there is a need for private and public sector collaboration on improving tourism in the District
- Methods and approaches to increasing tourism in the Kaipara district was discussed
- Resourcing of tourism promotion was explained and discussed
- The economic and social challenges to developing tourism in the Kaipara district was highlighted
- It was emphasised that future growth should be sustainable.

Council direction:

Continue as presented.

2. Kickstart programme update November 2020

Di Bussey (PGF programme Manager) presented this item via teleconference.

The following matters were raised:

- Emphasised that there is need to ensure that proper process is followed to minimise any risk in relation to contractual obligations, existing or new consents, and resourcing/implementation of projects
- Implications of implementing the projects and developing related assets was discussed. It was noted that where the Council takes on new assets, careful consideration of the implications was needed
- Funding sources and implications for projects was explained and discussed.

Council direction:

3. Mangawhai Spatial Plan - engagement outcomes

Paul Waanders (District Planner), and Michael Campbell (Consultant, Campbell Brown) and Kobus Mentz (Consultant, Urbanismplus) presented this item.

The following matters were raised:

- Development trends and feedback were explained. It was noted that there is a need for sustainable and managed development to ensure that the environmental, social, and economic aspects of Mangawhai are acknowledged
- It was noted that the Plan has an element of flexibility and does allow for future growth in a measured approach
- Proposed land use and zoning allocation principles were explained in the context of present and future development in and around Mangawhai.

Council Direction:

Continue with preparing final version for adoption by Council in December

4. Kaipara District Spatial Plan – Ngā Wawata – 2050 – Our Aspirations

Paul Waanders (District Planner), Michael Campbell (Consultant, Campbell Brown), and (Joao Machado, A&R Consultants) presented this item.

The following matters were raised:

 It was noted that Central Government may use the spatial plan to inform their plans for future infrastructure investment

- It was emphasised that the spatial plan needs to be regularly reviewed
- The structure of spatial planning and the way it fits together was described and discussed. It was noted that one spatial plan would be stitched together for the Council to adopt, which will help inform the District Plan.

Council direction:

- Include a disclaimer into the document that the document does not include the updated NRC climate change and sea level rise information as that won't be available until early 2021
- Ensure that assumptions that are used to come to findings are included on all maps to ensure that it is clear for readers
- Make clear that decommissioned train lines are in fact decommissioned train lines
- Page 52 zoom out on the north agricultural delta map
- Use plain professional English throughout the document
- Continue as presented.

5. Policy work programme update report

Shireen Munday (Policy Team Leader) presented this item.

The following matters were raised:

- The Freedom Camping Bylaw was discussed. It was noted that the Council made the decision to not make a policy at a previous Council Meeting
- It was agreed that de-coupling the bylaws was the most effective and efficient way to conduct any review.
