1. Dargaville Racecourse presentation

Representatives of the Dargaville Racecourse project made a presentation in relation to the development of the Dargaville Racecourse.

The presenters raised the following matters:

- Discussed the history of the project, governance organisation, and discussions with previous and current government to date
- Explained the challenges and dynamics of the ownership and legislative matters connected to the land
- Emphasised that the racecourse provides many opportunities for community development for the Dargaville area
- Outlined the project concept and goals.

Elected Members raised the following matters:

- Discussed the relationship between the project and the spatial plan
- Emphasised that the Council must ensure that any process it is part of, must be transparent and accountable.

2. Water Services Bill
