Business Support Package Survey Response

Summary

The survey was promoted via:

- The council website and face-book page
- Community and business networks
- Local media
- The People's Panel

We received 471 responses to the survey during the 17 days it was open to the public. Most responses were generated through emails or the website, and we also offered a telephone survey for those with no on-line option.

The following summary of responses indicates the level of support for the initiatives outlined in the proposal, including key themes to be considered in developing criteria and processes and information that may need to be clarified.

Feedback

Question 1

I support providing a hardship grant to hospitality businesses to contribute to their annual food safety and alcohol related compliance fees charged by Council. n=469



- Comments (11) Key Themes: Support for the reduction of fees for between 6 months to one year.
- Clarification required on the category of businesses that will meet the criteria i.e those who
 require council registration fees. Six comments noted that hairdressers also paid an annual
 council licence fee.

Question 2

I support providing hardship grants to commercial and industrial businesses in the District to offset a proportion of their rates up to a maximum of \$500. n=465



- Comments (14) Key Themes: Transparency of application process, criteria and monitoring
 required to demonstrate that rates relief is passed on to tenants and the impact the grant has
 on recovery of business operation.
- Clarification of scope of businesses within this criteria e.g. home-based, accommodation, farmers

Question 3


I support providing hardship grants to campground operators who lease council owned land to offset a proportion of their rates up to a maximum of 500. n=466

- Clarification required on how this could be managed effectively for as many businesses as possible e.g. group sessions/sector-related/marketing and promotion. More details required.

Other Comments

Themes: (relevant to the business package proposal)

- People are concerned on the impact on their rates or council debt.
- Request for general support for all ratepayers who have been impacted by loss of income due to COVID and struggling to pay current and projected rates.
- Transparency of process to track the beneficiaries, the source of funding and the total cost.
- Staff costs and council stance on maintaining salaried positions

- Need to develop an economic development plan to support future sustainable practice
- 48 comments support the actions being taken by council.
- 33 comments are not supportive of council taking on what is perceived as a central government role to support business in a recovery package. There is confusion on this being seen as "hand-outs" of money, not offsetting of council fees and costs.
