

# Sport New Zealand Rural Travel Fund 2019/20 Round Two: Summary of Applications

## Purpose/Ngā whāinga

To provide the Rural Travel Fund Committee the relevant information to award grants to community individuals and/or groups.

## Executive summary/Whakarāpopototanga

The Rural Travel Fund scheme is a partnership between Sport New Zealand and Kiwi Sport, to assist the development of junior sport in rural communities by providing a travel subsidy. The Kaipara District Council usually distributes this through two funding rounds in March and August. Due to the Covid-19 lockdown the Awards & Grants Committee meeting scheduled for March 2020 was postponed until New Zealand reached Level 1 and sporting events were able to operate.

The balance available for the Committee to distribute in the second round for 2019/20 is \$11,000.00 this is made up of a grant of \$10,000.00 received in February 2020 and \$1,000.00 of previously unallocated funds.

Fourteen applications totalling \$21,998.95 have been received and all applications meet the criteria for funding.
