

# Sport New Zealand Rural Travel Fund 2020-2021 Round One: Summary of Applications

#### Purpose/Ngā whāinga

To provide the Rural Travel Fund Committee the relevant information to award grants to community individuals and/or groups.

## **Executive summary/Whakarāpopototanga**

The Rural Travel Fund Scheme is a partnership between Sport New Zealand and Kiwi Sport, to assist the development of junior sport in rural communities by providing a travel subsidy. The Kaipara District Council distributes this through two funding rounds per year, usually in March and August. Due to the Covid-19 lockdown the funding rounds for 2020 were adjusted to ensure New Zealand had reached Level 1 and sporting events were able to operate.

The balance available for the Committee to distribute in the first round for 2020/21 is \$11,175.00 this is made up of a grant of \$10,000 received for this funding round and \$1,175.00 of previously unallocated funds.

Six applications totalling \$7,394.92 have been received and all applications meet the criteria for funding.
