 - a. Advertising will occur via seek/website and other professional forum in late January 2021 for 3 to 4 weeks
 - b. Shortlisting and interviews by the delegated panel in February
 - c. Panel recommends the preferred candidate to the March Council meeting for appointment.

- d) Notes that if the urgent decision-making process is exercised, the instances will be reported to the first Council or relevant committee meeting, in 2021.
- e) Delegates Councillor Curnow the authority under section 25(5) of the Civil Defence Emergency Management Act 2002 to declare a state of local emergency in the event the Mayor is unavailable over the recess period.
