## 5.1 Norfolk Pines Removal at Pahi

## 5.2 NTA Report on 2021-24 NLTP Funding

## 5.3 Representation Review 2021 - Final Proposal

That Kaipara District Council:

- a) Resolves, pursuant to section 19N of the Local Electoral Act 2001 and having considered and deliberated on submissions received on the Representation Review 2021 Initial Proposal, the Initial Proposal be adopted as the Representation Review 2021 Final Proposal with no changes.
- b) Notes that the arrangements for at least the 2022 triennial elections are as follows:
  - i. Kaipara District Council to comprise nine councillors elected under the ward system (specifically, eight general ward councillors and one Māori ward councillor) and the Mayor elected at large.
  - ii. Kaipara District Council be divided into four wards, these being: –
     Kaiwaka-Mangawhai General Ward (three general councillors) –
     Otamatea General Ward (two general councillors) Wairoa General
     Ward (three general councillors) Te Moananui o Kaipara Māori ward
     (one Māori councillor) .
  - iii. That no community boards are established.
- c) Issues a public notice (on 29 October 2021) detailing the final representation review arrangements.

### 5.4 Kaipara District Council Section 17A Service Delivery Review

- b) Approves Option One of this report which includes the following:

#### A. Three-waters

Address the prioritised points below in the order in which they appear. Noting that each item may be discounted in circumstances such as prohibitive cost or the inability to agree terms or conditions of a contract.

- i. Negotiate a Contract 798 out-of-contract four-year extension with the incumbent supplier.
- ii. Negotiate contract variations with Whangarei District Council's water supply, and wastewater & stormwater operations & maintenance contractors (two separate contracts) to operate & maintain Council's Three-waters reticulation networks, and either operate the water supply and wastewater treatment plants in-house, or by Whangarei District Council's in-house treatment plant operators (requires Whangarei District Council's agreement).
- iii. Tender (open or invited) a new four-year contract to operate and maintain Council's Three-waters infrastructure.

### **B. Flood Protection and Land Drainage**

i. Continue with the status quo.

## C. Waste Minimisation

- i. Continue with the status quo for one year; then
- ii. Explore the option of a joint contract/s with Whangarei District Council.

## D. Open Spaces

- i. Continue with the status quo.
- ii. Investigate contracting options which will include a review of possible cost-saving initiatives until an alternative to status quo is found.
